the organizers of Pferd International, Munich cooperate with EventClearing. We are responsible for the settlements as well as the collection of the nominal funds in advance and the distribution of the prize money after the tournament. The prize money will be paid immediately after the tournament to the account deposited by the rider or his employer at EventClearing.

Here you can specify adjustments i.e. regarding electricity and extra boxes, pay in advance with the credit card and communicate any other wishes directly to the organizer. If you do not wish to register, we will list the individual amounts below. Please make the payment by **21.05.2021 at the latest.**

#### **Important information:**

**Riders must deposit their companions (grooms, horse owners or family members) in their profile at EventClearing before the tournament starts, with their addresses. The data will be deleted in accordance with the data protection regulations four weeks after the event and will only be available to the competent authorities on demand if necessary. **Each rider can bring 1 companion. For riders with 3 horses or more 2 companions are allowed**

- Each rider must take two Corona self-tests per band (accredited person). Per test, the tab will be charged €7.50. Additional tests can be purchased for €7.50. IF required, FFP2 masks can also be purchased.
- Please note the validity of the tests PCR test 48 hours, POC test 24 hours, self-test in 4-eye principle daily. The detection of a complete vaccination against COVID-19 with a vaccine approved in the European Union is considered a negative test result from day 15 after the final vaccination, as well as corona recovered (an antibody test must be presented)
- The self-tests must be carried out in a 4-eye principle at our test stations on site.

There are 3 test stations:

- o **Station 1 (Gate 5)** for riders and accompanying persons staying at the hotel. The test will be carried out directly at the gate in the car, if the result is available, please take a photo of the test and ID and deposit it at EventClearing. Check-in is then carried out.
- o **Station 2 (passage to the examination site)** for companions and riders who stay overnight on the premises. The test is taken directly at the test station, if the result is available, please take a photo of the test and ID and deposit it at EventClearing. Check-in is then carried out.
- o **Station 3 (Lösmentor)** for officials, stewards, helpers. The test will be carried out directly at the gate in the car, if the result is available, please take a photo of the test and ID and deposit it at EventClearing. Check-in is then carried out.

Times are allocated for the test execution. Time slots are assigned for the tests every day. Please reserve the time slots in advance by Tuesday, May 25, 2021 at [info@hippo-gmbh.de](mailto:info@hippo-gmbh.de) or via WhatsApp on 0049 - 1520 - 174 647 7. A limited number of time slots are available. 6.00 - 6.15 - 6.30 - 6.45 - 7.00 (further in 15 min. clock) until 12.00.

Please observe the curfew 10 p.m. in case of an incidence of more than 100.
